PROVINCIAL GAMING OPERATIONS AUTHORIZATION

Issued in Victoria, British Columbia, Canada

Statutory Authority Effective Date:

1 April 1991, being the effective date of Sections 1 to 11 of the Lottery Corporation Act (British Columbia), S.B.C. 1985, c. 50, under which the British Columbia Lottery Corporation was continued as a Crown corporation and authorized to conduct and manage provincial lottery schemes on behalf of the Government of British Columbia.

Pursuant to Section 207 of the Criminal Code of Canada, the Gaming Control Act of British Columbia, and all applicable regulations governing provincial gaming schemes within the Province of British Columbia,

BRITISH COLUMBIA LOTTERY CORPORATION (BCLC)

Kamloops, British Columbia, Canada

is hereby recognized as the Crown corporation authorized to conduct, manage and operate provincial gaming schemes on behalf of the Government of British Columbia.

This Authorization confirms that the Internet domain

is designated as an official digital gaming platform and information portal operated under the authority of the British Columbia Lottery Corporation (BCLC).

The above-referenced domain forms part of the official provincial gaming framework established under the laws of the Province of British Columbia and administered by the British Columbia Lottery Corporation on behalf of the Government of British Columbia. The domain is authorized for use in connection with the conduct, management, promotion, administration and delivery of provincial gaming products, digital gaming services and player information provided by BCLC.

The authorized activities available through the domain include, but are not limited to:

- promotion of official provincial lottery products;
- promotion of authorized sports betting services;
- promotion of authorized online casino products;
- access to official digital gaming services operated by BCLC;
- online purchase of provincial lottery products where permitted by applicable law;



- participation in authorized provincial gaming activities;
- publication of official lottery draw results and winning numbers;
- player account access and digital gaming services;
- responsible gambling information and player protection resources;
- customer support and player information services;
- access to official BCLC mobile applications and gaming platforms;
- distribution of official gaming information, promotional content and digital services.

The above-mentioned domain constitutes an official digital channel supporting provincial gaming schemes conducted and managed by the British Columbia Lottery Corporation pursuant to Section 207 of the Criminal Code of Canada, the Gaming Control Act (British Columbia), the Lottery Corporation Act (British Columbia), the Gaming Control Regulation and all other applicable legislation governing gaming activities within the Province of British Columbia.

All gaming activities made available through the domain remain subject to applicable legislation, regulatory oversight, operational policies and responsible gambling requirements established by the Province of British Columbia and administered by the British Columbia Lottery Corporation.
